Below are questions and answers received for this bid. Please note that the deadline for questions has passed.

Is this bid just for the Lap Top Connect card? **No.**

Are there any laptops that need to be included? What are the specs for the laptops needed? **No.**

Is there a certain form factor for the aircards that you are requesting? Ex: PCMCIA Card, USB Card, Express Card. **The majority would be from the PCMCIA Card, but provider use for all three.**

Will you be using the same type of trunk mounted CPU set up that you currently have or will the set up in the vehicles be changed? **No, they will definitely be a change, plus an additional 100 pc express cards will be needed to provide a secure private network of 768K or better; that includes Telco, line, router configuration integration into our mobile IP structure.**

Does the Milwaukee Police Dept. prefer a certain brand or manufacturer for the Laptop Connection of 5GB? **Sierra Wireless.**

Is there a previous contract? **Yes.**

What was the cost of the last year's contract and is the same equipment as last year's contract? **The cost of last year contract was \$232,729.20.**

Who was the vendor? **AT & T Mobility.**

Would the city consider an all-in-one wall jack accommodating multiple connections on one plate? **No.**

Is the city willing to accept T&Cs from current Government contract I.E. WSCA (Western States Contract Alliance)? **No, the City will not accept any other T&Cs except our own.**

If that is the contract vehicle reference in the bid response, would that disqualify the vendor from the bid? **Yes. Any deviation would be considered a counteroffer and would subject the bid to rejection.**
